**NEW BUSINESS**

A. Budget Workshop – Overview of the Fiscal Year 2018-2019 (July 1, 2018 through June 30, 2019) Operating Budget, Capital Improvement Projects and Reserves

GM Robbins gave an overview of the District's fiscal year 2018-2019 Budget and turned the meeting over to Finance/HR Director Housley.

Finance/HR Director Housley presented the Board with a Power Point presentation with an overview of the District's 2018-2019 Budget.

The Board and Staff discussed capital expenditures to implement the District's curbside organic waste recycling program, including the two new solid waste trucks and the new CNG sewer Vactor truck. Also discussed was how the District reorganized and has reduced its spending by doing projects in-house as well as cancelling membership dues. Finance/HR Director Housley stated that the District aggressively went after paying its unfunded liabilities, all of which has helped in freeing up cash flow for capital expenditures.

There was discussion about the dissolution of RDA's, what the District's portion is and how it was used to pay off debt and comply with SB-32, the California Global Warming Solution Act of 2006.

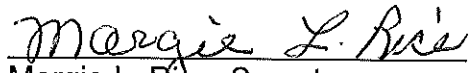
