

1 ORDINANCE NO. 33

2 A ORDINANCE OF THE BOARD OF DIRECTORS OF THE
3 MIDWAY CITY SANITARY DISTRICT OF ORANGE COUNTY,
4 CALIFORNIA, SETTING FEES FOR THE USE OF BINS.

5 THE BOARD OF DIRECTORS OF THE MIDWAY CITY SANITARY
6 DISTRICT, of Orange County, California, does ORDAIN as follows:

7 Section 1. For all properties in the District requir-
8 ing bin service for trash and garbage collection, a collection
9 fee shall be established as follows; effective May 1, 1986:

10 A. For once per week pick-up, the
11 charge shall be \$39.00 per bin per month.
12 The determination of whether a user will
13 have once per week or twice per week col-
14 lection shall be at the discretion of the
15 Orange County Health Department or the
16 MIDWAY CITY SANITARY DISTRICT.

17 B. For twice per week pick-up, the
18 charge shall be \$49.00 per bin per month.

19 C. For pick-up three times per week,
20 the charge shall be \$54.00 per bin per
21 month.

22 D. For pick-up four times per week,
23 the charge shall be \$59.00 per bin per
24 month.

25 E. For pick-up five times per week,
26 the charge shall be \$64.00 per bin per
27 month.


28 F. Charges for residential bins for
29 10 days shall be \$39.00.

30 G. A surcharge of \$14.00 per pick-up
31 shall be added for each pick-up in excess
32 of the maximums set forth above.


1 Section 2: That all other Resolutions and Ordinances,
2 and parts thereof, inconsistent herewith be and the same are
3 hereby repealed to the extent of such inconsistency and no
4 further.

5 Section 3: The Secretary of the District is hereby
6 authorized and directed to cause a certified copy of this
7 Ordinance to be published in a newspaper of general circulation
8 and to be posted in three (3) public places within the District.


